This conference builds on the success of the last 4 Networks online event – [Together in the fight against environmental crime](#) in 2021 as well as the two previous conferences held in person in Oxford in 2017 and Utrecht in 2016.

International cooperation and alignment are very important when it comes to enforcement of EU environmental law. To improve the collaboration and alignment of enforcement, it is essential that enforcers have structural, personal and frequent contact moments where they can strengthen their network, exchange experiences and best practices, discuss ongoing cases and align their enforcement activities together.
